Dawn STURGESS & property (Scene 1)

STURGESS body is currently at Salisbury District Hospital. Awaiting transfer to **a mortuary**

Charles ROWLEY & property (Scene 2)

ROWLEY is currently at Salisbury District Hospital. Blood samples & swabs taken & confirm presence of Novichok

9 Muggleton Road, Amesbury (Scene 3)

Searches have concluded today 08/08/2018 with 7 exhibited swabs taken & along with a number of photos including a pair of jeans seized from the address.

Cedar Room, John Baker House, 16 Rolleston Street, Salisbury (Scene 4)

Swabs indicate that there is no contamination in the address & nothing of significance was found in the property during the search on 07/07/18 Images updated on CLIO. A decision as to whether to close this as a scene for CBRN.

Queen Elizabeth Gardens (Scene 5)

This scene remains the same. Search for blue lock box was completed but not located around the vicinity of the river.

Red transit van, index LG05 [PD] (scene 10)

The vehicle will be recovered by the military during the evening of 08/07/18.
